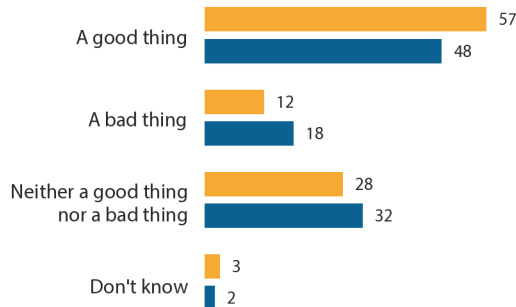

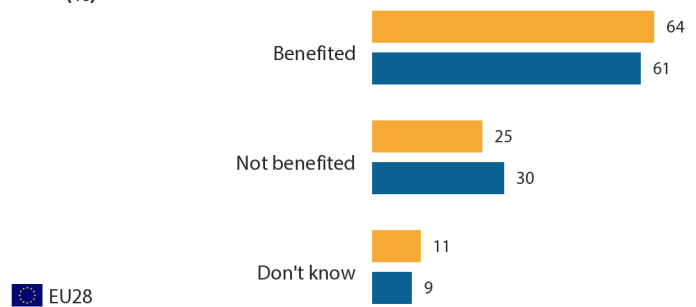
Q10 Generally speaking, do you think that (OUR COUNTRY)'s membership of the EU is...? (%)

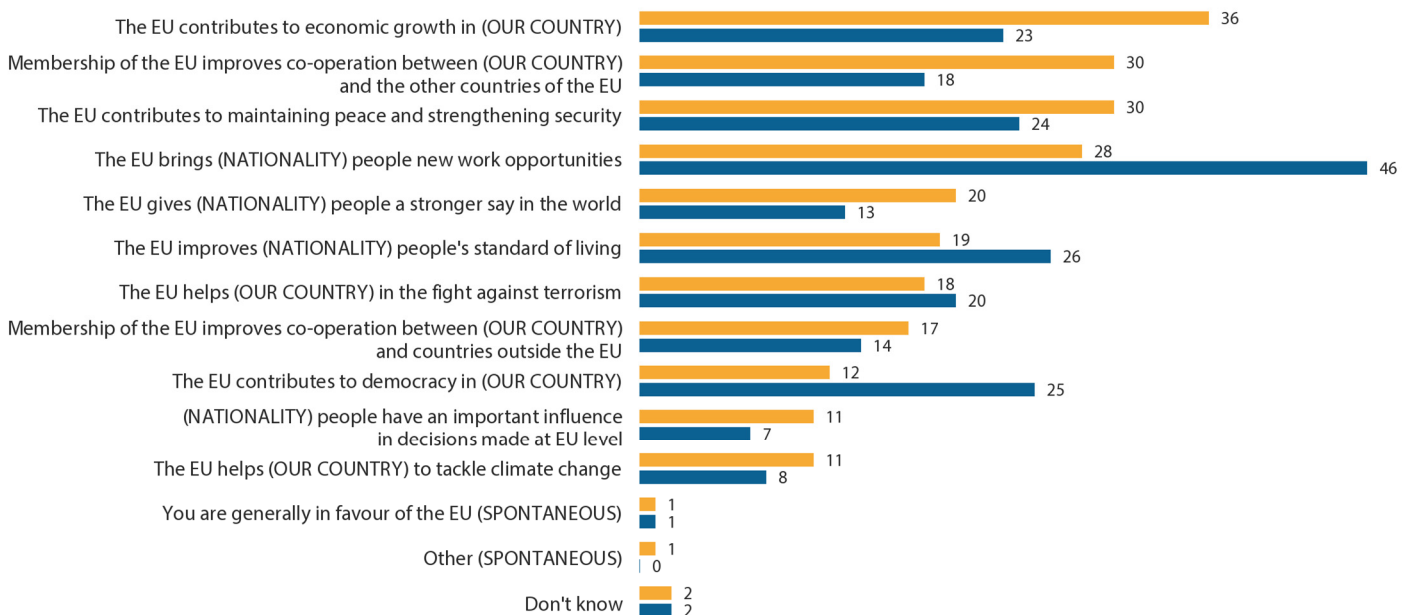

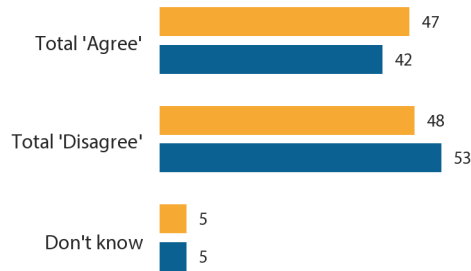

My voice counts in the EU (%)

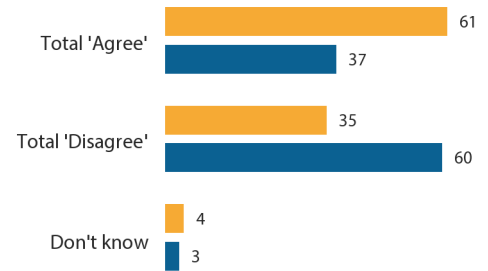

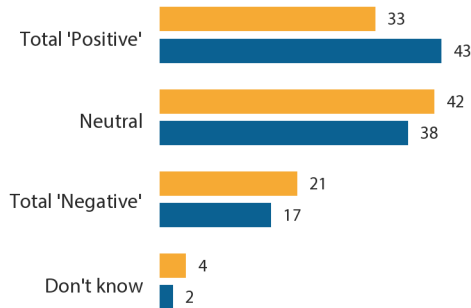

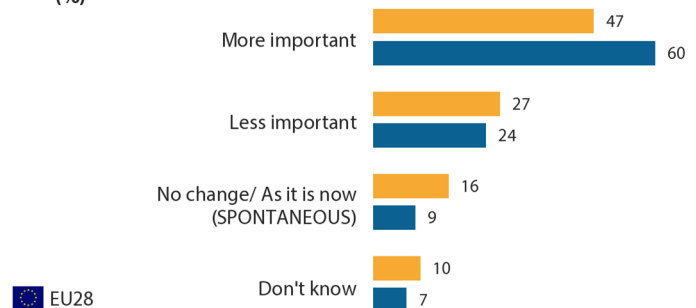
Q6 In general, do you have a very positive, fairly positive, neutral, fairly negative or very negative image of the European Parliament? (%)

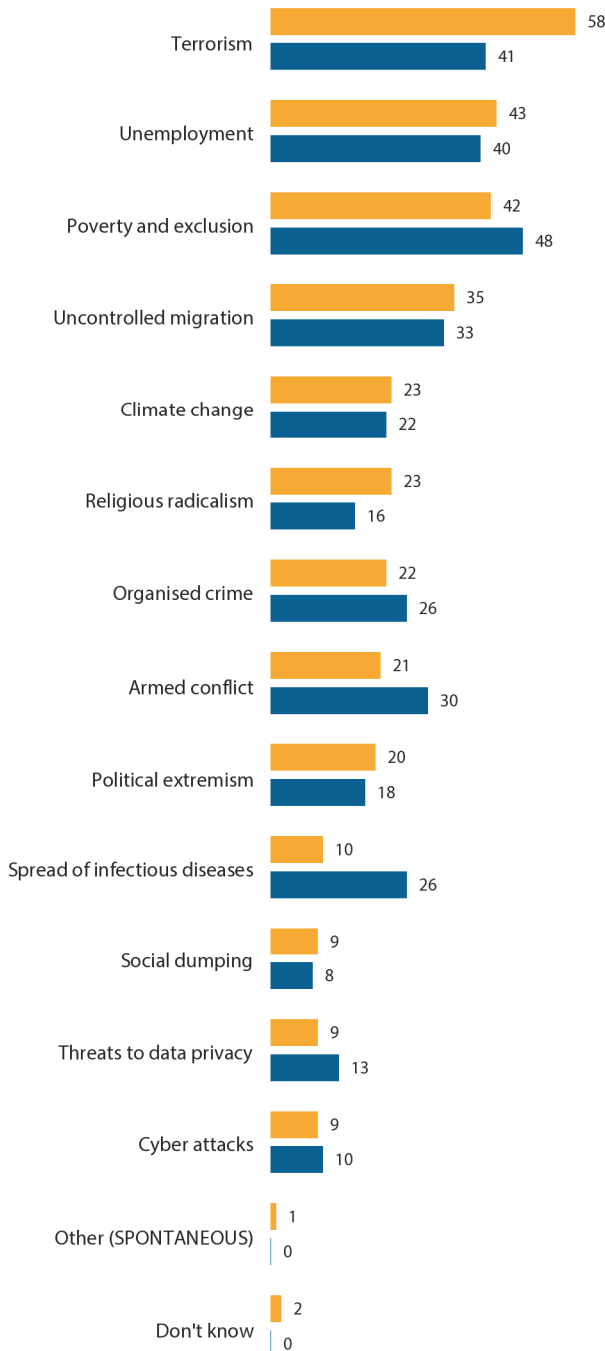

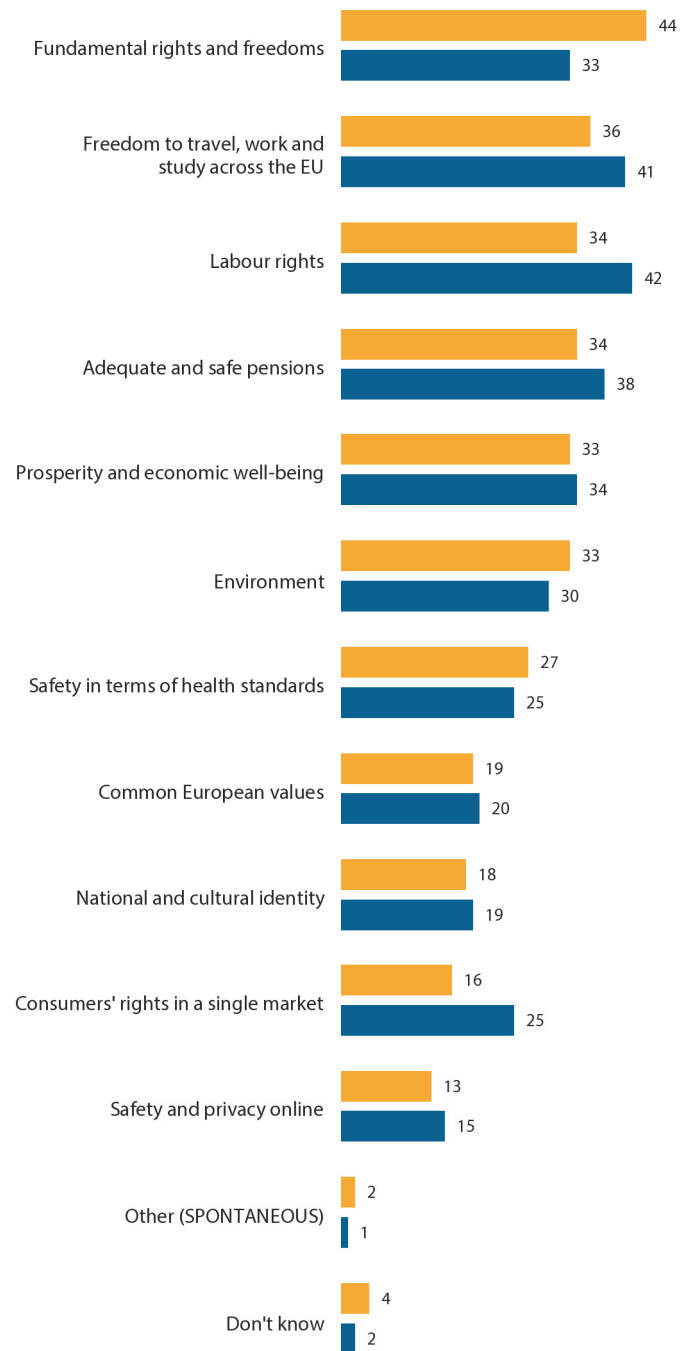

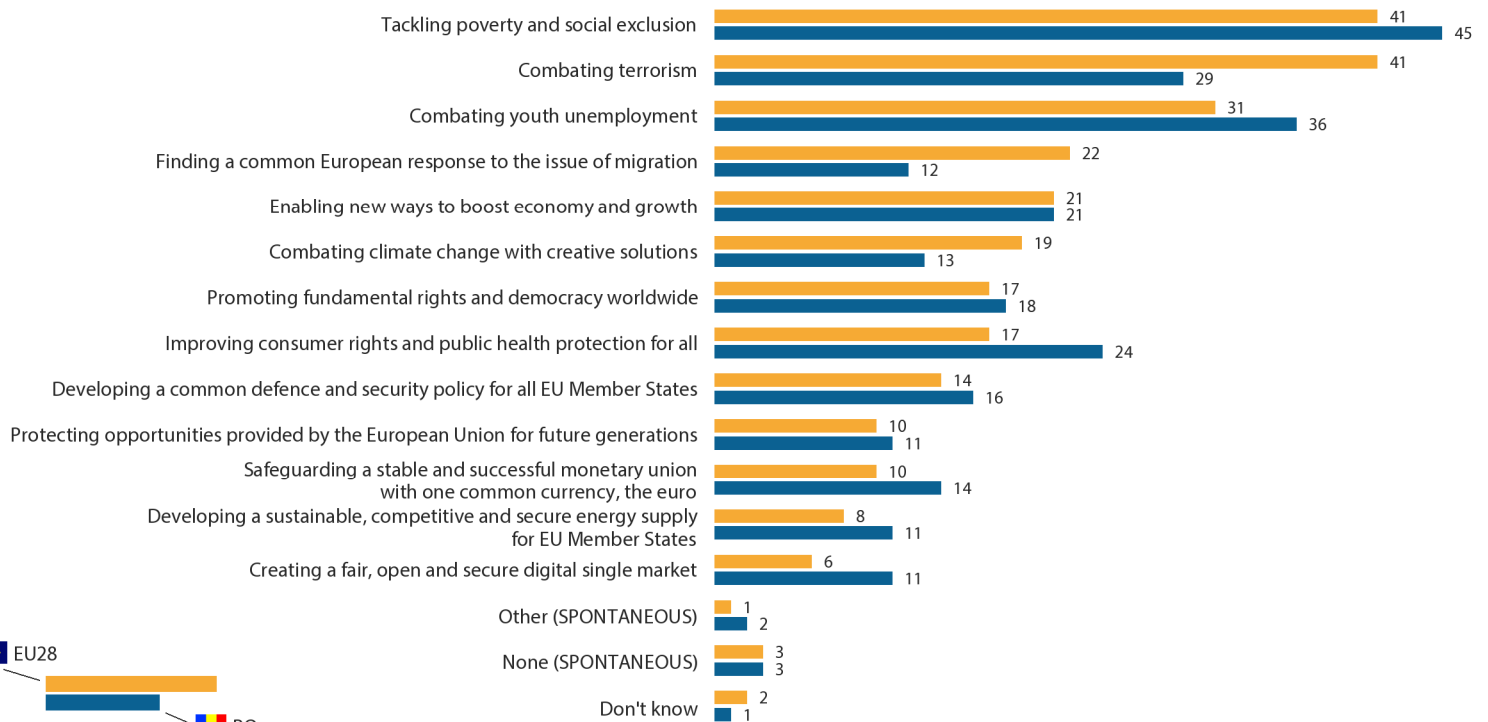
